- 3. Advertisement was published by the Company in English in Financial Express (Mumbai Edition), dated Wednesday 5th September, 2018 and in Marathi in Mumbai Lakshdeep dated Wednesday 5th September, 2018. The notice published in the newspaper carried the required information as specified in Sub Rule 3(v) (a) to (g) of the said Rule 20.
- 4. The Company has availed services of Karvy Computershare Private Limited (KARVY) as the agency for providing the remote e-voting platform.
- 5. The Voting rights were reckoned as on Friday, 21<sup>st</sup>September, 2018, being the cut-off date for the purpose of deciding the entitlements of members at the remote e-voting and voting at the Meeting.
- The remote e-voting period was open for three days which commenced on Tuesday, 25<sup>th</sup> September, 2018 at 09:00 a.m. and concluded on Thursday,27<sup>th</sup> September, 2018 at 5:00 p.m. on <u>https://www.evoting.karvy.com/</u>
- 7. The remote e-voting results on the KARVY E-voting platform were unblocked and downloaded on Friday, 28<sup>th</sup> September, 2018 in the presence of two witnesses Mr. Deepam Shah and Ms. Khadija Lokhandwala who are not in the employment of the Company and who have signed below in confirmation of the votes being unblocked in their presence.
- 8. After the time fixed for closing of the poll by the chairman, ballot boxes kept for polling were locked in our presence with due identification marks placed by me.
